ATTENTION: A \$40 dollar annual fee for temporary food vendors is required prior to the event. If you have already paid the fee at another local Health Department, send a copy of your receipt with your application to avoid additional fees. Make checks payable to: Culpeper Health Department. Certain fraternal, social and religious organizations are exempt from fee.
